## 1 About CHORAL

**As part of the UNITA Alliance, 14 excellent Doctoral Candidates (DCs) will enrol the CHORAL programme in Cultural Heritage.**

Coordinated by the Université de Pau et des Pays de l'Adour, **CHORAL (Cultural Heritage Outreach in Romance Languages)**, is a Horizon Europe Marie Skłodowska Curie programme co-funded by the European Union. It is tied to the [Cultural Heritage Hub](#), an international research network within the Alliance, which structures its research ecosystem facing cultural related challenges.

**CHORAL aims to train high-quality international researchers and to nurture the development of interdisciplinary, international and inter-sectoral research that addresses any aspect of Cultural Heritage.**

The successful candidates will enroll in PhD programs under **joint supervision** that will require an **international mobility**. Choral students will benefit from **dedicated events** and a **tailored doctoral training programme**.

Applications are open until March 22nd, 2024 for 14 grants on multiple PhD research topics in 7 Universities of the UNITA Alliance for fully funded 3-years PhDs, starting on fall 2024.

## 2 Timeline of the call, deadlines for submission, and results

In alignment with the *European Charter for Researchers* and the *Code of Conduct for the Recruitment of the Researchers* and the evaluation procedures set out by Marie Skłodowska-Curie Actions, CHORAL will establish 3 successive calls – in January 2024, 2025 and 2026. The **schedule for CALL#1** is detailed in the table below (**Dates may however be subject to some variations**).

At the end of **CALL#1**, **14 PhD candidates** will be recruited for a duration of 36 months. The best ranked proposals will be short-listed for interviews, and applicants will be informed of the output of this step via a dedicated online platform – See all details for applying in Section 3.

### 3 Information about PhD topics

Candidates cannot propose their own subjects nor write a proposal. Research topics have been proposed by habilitated supervisors from the Doctoral Schools of UPPA and the implementing partners after a call launched towards the academic community of the programme. Candidates must choose among the subjects posted on the CHORAL interface.

CHORAL places cultural heritage and the cultural and creative industries at the very heart of the research programme. It is designed to train the future generations of Cultural Heritage experts in Europe, with the scope of covering all aspects of cultural heritage, with a special focus on remote or endangered areas.

25 proposed PhD topics **address any aspect of cultural heritage** (as defined by UNESCO) and all within one of the following themes:

- **Study and preservation of tangible CH**: visual arts, monuments and buildings, archaeological sites, palaeontology, industrial archaeology, places of memory, museums and collections, art conservation and restoration, legislation for the protection of cultural and natural heritage
- **Intangible CH and identity narratives**: oral traditions, romance languages and literature, performing arts (music, dance, drama), rituals, travels, cultural identity, religion, collective and individual memory, migrations, vulnerable communities, gender studies, transnational history, values, human rights
- **Enhancement and dissemination of cultural and natural heritage**: tourism and valorisation, education, communication, heritage management, digitisation/digital tools, storytelling, institutions and heritage
- **Innovation policies for the development of marginalised areas**: natural heritage and cultural landscapes, climate impact on mountain/rural areas, flora, agriculture, and landscape, culture and food, fauna, livestock farming and biodiversity sectors to ensure the economic strength of mountain regions and cross-border communities.




## 4 Application procedure

In order to apply to **CALL#1**, applicants must comply with the following requirements:

### 4.1 Registration on the application platform

First of all, the candidate must go to <https://aap.univ-pau.fr>, and create an account to have access to **1<sup>st</sup> Call for applications for HORIZON-MSCA-Cofund CHORAL PhD**, and register his/her profile. Once the account created, the applicant can have access to the call and complete the form. To go further in his/her application, he/she must check that his/her application meets the **Eligibility criteria** described in 5.3.1. If you don't speak french, don't forget to change the platform to english.

### 4.2 Submission of a complete Application Form on the dedicated platform

When the previous steps are completed, candidates must submit their Application Form and all required documents, on the following dedicated online application and evaluation platform <https://aap.univ-pau.fr>: each applicant will receive an automatically generated confirmation email when the complete application document is successfully received. A Helpdesk service is available throughout the process at [application-helpdesk.choral@univ-pau.fr](mailto:application-helpdesk.choral@univ-pau.fr)

**IMPORTANT: The application must be in English and uploaded in PDF format. Only complete applications will be taken into consideration.**

The Application Form should contain all the following mandatory documents:

1. A full CV (Template provided – See 7. Annex I) that includes all personal information, education background, research activities (if any) and information about two referees

2. **Two Reference letters (in a single PDF file):** each referee will submit a letter concerning the applicant's previous research activities and the applicant's research capacity and working experience
3. **A personal statement (Template provided – See 7. Annex I - maximum of 3 pages)** that includes general motivation letter for participation in CHORAL and the research topic, qualifications and achievements, career development objectives, collaboration requested beyond higher education sector for short stays
4. **An ethics and security issues self-assessment (Template provided - See 7. Annex I)**
5. **A copy of the Master's degree and academic transcripts** translated into English; **for candidates with a Master's degree in progress during the academic year of the call, marks and rankings corresponding to the first semester of the Master 2.**
6. **Copies of certificates of English language proficiency** (for non-English native speaking applicants)
7. **Copies of a valid identity card (for EU citizens) or a valid passport (for visa application if selected)**
8. **A declaration on honour (template provided)** about the conformity of the mobility information declared.

NB: this **platform** will allow registered applicants to upload all application materials. Evaluators will be only able to access material through the online platform for the candidates they will have to evaluate. The platform will guarantee confidentiality of application material, which will only be accessible to the Steering Committee and evaluators involved in the selection process. From the call deadline to the appointment of the Fellows, the website will be updated continuously, and candidates will be notified of their status in the selection process as soon as a new step has been reached.

## 5 Evaluation and selection

### 5.1 Successive stages in the selection process

The Research projects and their associated candidates will be selected according to a very rigorous process, taking place in successive stages where different committees will be involved:

1. **An Eligibility committee** will first check that all Eligibility criteria mentioned in 5.2.1. are met.
2. **A Review panel with three external experts** will evaluate: CV, personal statement, reference letters, degrees and marks. **The best-ranked proposals for each PhD topics will be short-listed for interviews, and applicants will be informed of the output of this step by the PM, via the online platform.**
3. **Interview panel:** for each applicant, **an interview panel** will perform remote evaluations. After all the interviews, a proposal ranking list for each PhD position will be issued, including a principal and a reserve list.
4. **Applicant Selection Committee: the top scoring applications will be presented to the Steering Committee who will endorse the final funding decision.** Once the final short and reserve lists issued, applicants will be informed of the output of this step by the PM.

Selections will be made regardless of gender, nationality, religion, ethnicity and cultural background, but aiming for a good balance among the group.

### 5.2 Description of the evaluation and selection process

For the evaluation of the candidature, 3 steps can be distinguished:

#### 5.2.1 STEP 1: Verification of the Eligibility criteria of the candidates

In order to participate in CHORAL program, the **applicants** will have to demonstrate they satisfy the following **eligibility criteria**:

Criterion	Rule
<b>Diploma</b>	On the date of application, the candidate must be a <b>doctoral candidate</b> , i.e not already in possession of a doctoral degree at the deadline of the call, but in possession of a <b>Master's Degree enabling to do a PhD in Social Science, Arts, Architecture and Humanities applied to Cultural Heritage</b> .
<b>Seniority</b>	<b>Any candidate in possession of the required diploma</b> can apply regardless of the year of obtainment of the diploma.
<b>Mobility rule</b>	<b>MSCA rule:</b> Researchers must not have resided or carried out their main activity (work, studies, et.) in the country of the <b>recruiting university</b> for more than 12 months in the 3 years preceding the date of the call deadline. Compulsory national service, short stays such as holidays, and time spent as part of a procedure for obtaining refugee status under the Geneva Convention are not considered.
<b>Nationality</b>	The call is open to researchers of <b>any nationality</b>



<b>Language</b>	<p>Applicants who are non-native speakers of <b>English</b> are required to provide proof of proficiency in the language, as CHORAL's working language is English.</p> <p><i>A minimum B2 level in English is required. A variety of English Language tests may be provided, such as TOEIC, TOEFL, TOEFL Internet-based Test, IELTS, CPE, PTE (Pearson Test of English), CAE. Please check to be sure your test results are still valid (some tests are valid for 2 years, whereas CPE and CAE results are valid for life)</i></p>
<b>Number of applications</b>	Possibility to apply to 3 PhD topics offered within a call for proposals.

## 5.2.2 STEP 2: Evaluation of the Research Proposal and the Applicant's credential

Applications that meet the **Eligibility criteria** described in 5.2.1 will be sent to three external experts for review, based on the **reference letter**, the **extended CV**, and the **personal statement** (See 4.2) and be scored against the weighing specify below.

The score will be calculated by the PC and The PM which will result in a ranked list for each doctoral candidates position. The threshold to reach the interview will be 70 out of 100 and the maximum number of applicants invited for interviews will be 4 for each positions offered.

For the evaluation at any of the following steps (eligibility check, application review, and interview), applicants can appeal against the decisions, based on administrative or procedural arguments only. If the request is successful, the application will be re-evaluated, the candidate interviewed or re-interviewed or included (re-included) in a list for funding.

### 5.2.3 STEP 3: Criteria for interviews

The Management Team of CHORAL (PC and PM) will combine the feedback from the 3 independent reviewers, and calculate the **average score** which will result in a **ranked list** for each doctoral candidates position. It will determine which applicants will be invited for interview based on the rank order.

At the interview stage, short-listed candidates will be invited to present and discuss their applications during an **online interview** that will consist in a presentation of their **curriculum vitae** and motivation followed by questions and answers.

**Interviews** will consist in a presentation given by the candidate about his/her background, previous and recent research experience and his/her professional project and motivation for the thesis project of his/her choice. During the interviews, the candidates will be evaluated on the following criteria: general presentation of the project, research capability and leadership potential.

**The threshold to be considered for the final ranked list is 70 out of 100.**

### 5.2.4 Ethical issues

The CHORAL program will comply with the ethical principles of Horizon Europe. Within CHORAL, ethical issues should be considered for all projects.

The **ethics issues check-list** (see 7. Annex I) is part of the application form. This list must be completed to identify ethical matters relating to their research proposal: 1. *Human embryos and fetuses*; 2. *Human beings*; 3. *Human cells or tissues*; 4. *Personal data*; 5. *Animals*; 6. *Non-EU countries*; 7. *Environment, health & safety*; 8. *Dual use*; 9. *Misuse*; 10. *Ethics issues*. If applicable, applicants are asked to describe in their **Research proposal** how the **ethical requirements** are considered. Moreover, the CHORAL PhD Fellows will have access to multiple sources of information and guidance regarding ethics and research integrity and they will have the opportunity to develop this transferable skill through courses such as the “Ethics and Integrity in scientific research” course, which will be mandatory. Moreover, partners of the project (participating in secondments or training) will have to commit themselves to follow Horizon Europe ethical principles, rules and guidelines.

### 5.2.5 Appeal redress procedure

A Quality Committee will be in charge of the redress procedure that enables to examine any appeal against the output of the evaluation at any following steps: eligibility check, application review, and interview. Applicants will be able to appeal against the decisions, based on administrative or procedural arguments only. The candidates will have 10 days

after the notification of the results of each selection process to appeal. The appeal procedure will have to be completed thanks to redress request form available on CHORAL website : <https://www.research.univ-unita.eu/en/choral-project/for-applicants.html>

**CHORAL will ensure a truly independent, transparent, excellent and professional evaluation of all applications submitted under the different calls. The openness and transparency of the selection process of CHORAL will be in line with the European Charter and Code.**

### 5.2.6 Processing of Data

UPPA will process the personal data of the applicants to manage their application in accordance with our selection processes legitimized by the consent that applicants give when applying to the call. UNITA Alliance will not transfer their data to third parties, except in to the experts evaluation panel, and will keep them for a maximum of two years, except in case of legal obligation.

## 6 Beginning the PhD

### 6.1 Estimated time-to-contract

- **Before the end of June**, after the process of evaluation will be completed, the Candidate will be informed of his/her chances of joining CHORAL.
- **Selected candidates will have 10 days from the notification of the final decision to confirm their acceptance. Then, selected candidates will be contacted by the HR Departments of the recruiting university and conclude the administrative part in July.**
- **Indicative starting date: September 2024**

N.B.: the CHORAL doctoral fellowship does not exonerate PhD candidates from paying standard university tuition and fees, or any other mandatory required toward the universities.

### 6.2 Working conditions of the Fellowship

In each PhD position, the doctoral candidate is enrolled in two universities: the **recruiting** university and the **co-supervising** university. Each doctoral candidate will be hired by the recruiting university for a **36-month Research work contract** (doctoral contract), governed by the **recruiting university national regulations**.

In all cases, the employment conditions for doctoral candidates will follow the **Code of Conduct for the Recruitment of Researchers**. Doctoral candidates will be subject to employment conditions and entitlements similar to those of permanent researchers regarding working hours, paid annual leave, health care coverage, maternity/paternity leave, pension, and unemployment insurance. They may also be eligible for a family allowance depending on their individual situation. Gender equality will be guaranteed throughout the recruitment process. Support will also be provided to researchers with disabilities and researchers holding refugee status. Applicants having taken a career break may be eligible for the project, as long as they apply within three years from obtaining their Master's degree.

The **monthly gross salary will depend on the recruiting country**. The following list presents an indicative gross salary after employers' taxation, provided as guidance.

- France: 2131,50€/month (approximative net salary 1713€/month over 12 months (further information <https://www.salaire-brut-en-net.fr/>))
- Italy: 2270€/month (approximative net salary 2005€/month over 12 months)
- Spain: 2164€/month (approximative net salary 1701€/month over 12 months (further information <https://taxscouts.es/calculadoras/calculadora-de-sueldo-neto/>))
- Romania: 2700€/month (approximative net salary 1603€/month over 12 months (further information <https://www.calculator-salarii.ro/calcul-salariu-net/>))

**CHORAL fellows will benefit from the following advantages:**

1. A **mobility allowance of 4500€** to undertake research-related mobility such as travel and accommodation.
2. A **travel allowance of 3500€** over the 3 years to enable fellows to attend international conferences.
3. **Personalized training, individual support:** doctoral students will design a **Personal Career Development Plan (PCDP)** at the start of their thesis and have access to a wide variety of trainings and workshops.

## 6.3 Principal benefits of the position

### 6.3.1 Support services

Upon acceptance of the CHORAL fellowship, laureates will be contacted by the International Welcome Desk. Its staff members will assist the Fellows before and after their arrival with administrative matters like obtaining a visa or residency permit for France (if required), providing leads for housing as well as information about the university registration process, French health insurance, French income tax, etc. **Dedicated guides** are available ("Arriving in France", "Foreign students – a roadmap", "The PhD Student Guide"). Other support services are also available at the university, such as the Erasmus Student Network (ESN) student association which offers social activities, monthly polyglot nights, etc. A **buddy programme** is available to help with relocation, cultural aspects, and social life.

### 6.3.2 Personalised supervision

A personalised supervision that will combine **counselling on career development, academic supervision, peer exchanges, interaction with external partners and training through:**

- A **Personal Career Development Plan (PCPD)** set up in the first 3 months to address a **research plan, the publication strategy, and career development activities** both in regards to **scientific and non-scientific skills, and the training programme offered at UPPA and via partners**; Meetings, annual progress and evaluation reports will help to make recommendations and evaluations regarding the training and the progress of the project
- **Exchange between peers and external networking via the participation in internal and external meetings and conferences**

### 6.3.3 Gender dimension and other diversity aspects in research

Being aware of the difficulties that gender bias can represent at later stages of career, CHORAL will involve young researchers regardless gender as well as senior women researchers in management and research role which will greatly impact on the empowerment of high potential actors towards future leadership in Cultural Heritage. CHORAL will implement an equal opportunities procedure for the doctoral candidate's selection, where excellence will be the main selection criteria, taking into account a gender mix. Based on the Gender Actions Plans of each hiring entity, CHORAL will promote equal gender participation in defining special measures and targets to promote equal opportunities.

### 6.3.4 Training

In order to be awarded their PhD, doctoral candidates will have to complete a minimal number of hours or a minimal number of ECTS, according to the national legislation. The CHORAL programme requires that doctoral candidates follow a tailored programme that covers a multidisciplinary training aimed at providing them with a holistic approach of cultural heritage, languages, cultural management and digitisation.

### 6.3.5 Career

CHORAL aims at **enhancing the career perspectives and employability of the doctoral candidates**, in line with the Europe Skills Agenda. CHORAL will help to the completion of a PhD in top-level research universities within the world-wide acknowledged MSCA program. CHORAL will give the opportunities to rely on international, intersectoral an in-

terdisciplinary network for future collaborations and opportunities by pushing the doctoral candidates to go beyond their boundaries.

The program will include training with non-academic partners which will ensure the alignment between employers' needs outside academia and skills development. As a result, they will develop a realistic perspective on the requirements of jobs in such and gain an important understanding of how scientific, experimental knowledge can be applied in non-academic environments. This will contribute to broaden their scientific perspective, increase their skills and innovation capacity as well as their attractiveness towards the private sector.

### 6.3.6 Mobility

All CHORAL doctoral candidates will be associated to 2 Universities in the UNITA Alliance awarding the PhD co-diploma complemented by short stays at associated partners. The proposed combination of secondments and short stays promotes mobility and exposes CHORAL candidates to different research environments. Therefore, each doctoral students must spend **9 months outside the recruiting university including at least 6 months in the co-supervising university**. The other 3 months can also be spent in another entity, increasing the international exposure of the doctoral candidates.
